








Strategy for Phase III (2012-2014)



Towards a '4D' Strategy

- Valuing Diversity in all Euromed countries
- Promoting civil society role in reforms and transitions
- Reinforcing the original ALF mission (2004)

"To be effective, Intercultural Dialogue must be set within a context of respect for fundamental rights, and may then become a powerful vehicle of democratisation" (High Level Group) Advocating for ICD as an asset for Development

Strategy for Phase III (2012-2014)



The Challenges

- Some Good News
 - Phase III pledges (State of play/document distributed)
 - EU Grant Contract on the way (6,9 M euros)
 - MS contributions (4,15 M euros)
- Budget (12.9 M euros) is not secured
- Extra sources of funding:
- UK Arab Partnership (440,000 GBP)
- Collaboration with EU Partnership for Democracy
- Complexity for planning and managing Budget.
- Fund-raising. Opportunities for the Networks

Increasing the efficiency of the Headquarters

The ALF Secretariat (1)



Positive Assessment for Phase II

- More professionalism in planning and implementing
- Ensure better standards in financial management
- Improved capacity and better coordination among Units.
- Participation of all Units and Staff in Networks life

Need to improve Staff work conditions.

- Survey and Performance Appraisal: excessive workload. Admin & finance procedures consume 50% time. Need to sdimplify more.
 Definition of responsibilities. Institutional and professional uncertainty .
- O How to improve work condicions and quality and Staff efficiency?
 - More participation.
 - More clarity in tasks segreagations
 - More responsibility.
 - More ownership.
 - New Orgranigramme next BoG.

Increasing the efficiency of the Headquarters

The ALF Secretariat (2)
